## 4. First-aid measures

### 5. Fire-fighting measures

**Flammable class:** Nonflammable

**Suitable extinguishing media:** Use extinguishing media appropriate for surrounding fire.

**Fire fighting equipment:** Firefighters should wear proper protective equipment and self-contained breathing apparatus with full face piece operated in positive pressure mode.

### 6. Accidental release measures

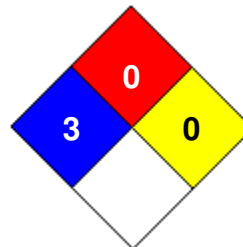
